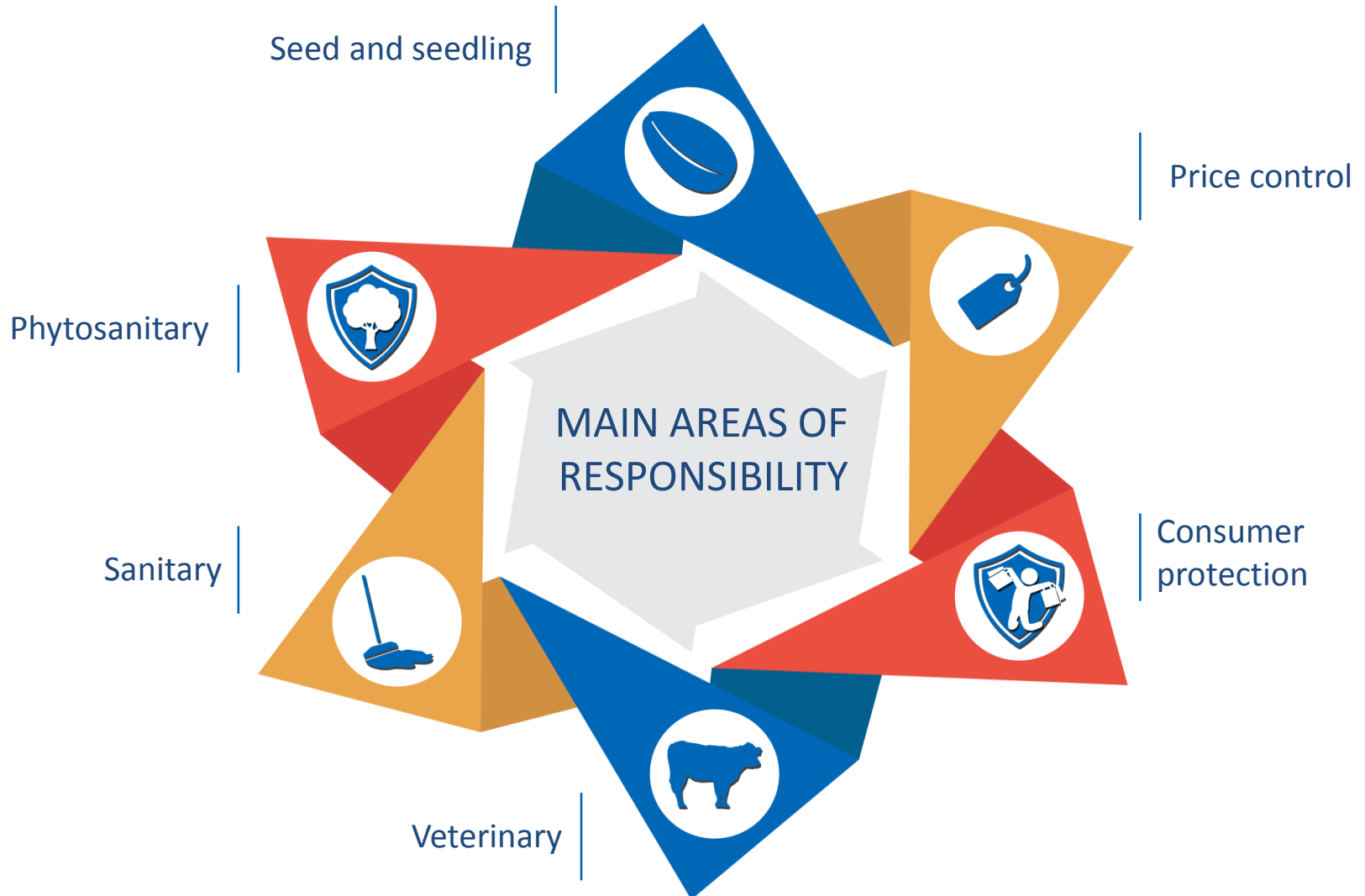

AUTHORIZATION OF LABORATORIES
ON PROVIDING TESTS FOR
PERFORMING OFFICIAL CONTROL

KEY POSITIONS OF THE LAW:

- BASES AND PROCEDURE ON OFFICIAL CONTROL PERFORMING
- REQUIREMENTS FOR FOOD BUSINESS OPERATORS
- FOOD MANUFACTURING AND CIRCULATION REQUIREMENTS
- HEALTH AND HYGIENE REQUIREMENTS FOR FOOD HANDLERS
- INTERNATIONAL TRADE REQUIREMENTS, ETC.



LAW OF UKRAINE “ON PRODUCTION AND CIRCULATION OF ORGANIC AGRICULTURAL PRODUCTS AND RAW MATERIALS

SUBORDINATE LEGISLATION SETS REQUIREMENTS FOR ORGANIC FOOD MANUFACTURING:

- ✓ ORGANIC PRODUCTS (RAW MATERIALS) OF PLANT ORIGIN
- ✓ ORGANIC PRODUCTS (RAW MATERIALS) OF ANIMAL ORIGIN
- ✓ ORGANIC PRODUCTS OF SEAWEED AND AQUACULTURE
- ✓ PROCEDURE FOR MAINTAIN THE REGISTER OF ORGANIC PRODUCTS (RAW MATERIALS) MANUFACTURERS

ALSO APPROVED:

- ✓ NATIONAL LOGO FOR ORGANIC PRODUCTS (RAW MATERIALS)
 - ✓ LISTS OF INCOMING PRODUCTS THAT ARE ALLOWED TO BE STORED IN THE PRODUCTION UNIT

KEY PROBLEMS CONNECTED WITH CURRENT LEGISLATION IN SPHERE OF OFFICIAL CONTROL IN THE ORGANIC SECTOR:

▪ **ENABLE ENVIRONMENT FOR PUTTING INTO CIRCULATION FAKE ORGANIC PRODUCTS**

OUTCOME:

- ✓ VIOLATION OF CONSUMERS RIGHTS AND UNFAIR COMPETITION
 - ✓ DECLINE CONFIDENCE TO THE ORGANIC PRODUCTS MANUFACTURED IN UKRAINE

▪ **DISCREPANCY BETWEEN UKRAINIAN AND EU LEGISLATION**

OUTCOME:

- ✓ DECLINE CONFIDENCE TO THE OFFICIAL CONTROL SYSTEM
-

▪ **LACK OF SUBORDINATE LEGISLATION**

OUTCOME:

- ✓ IMPOSSIBILITY OF REALISATION OF STATE SERVICE FUNCTIONS



DRAFT LAW “ON MAIN PRINCIPLES AND REQUIREMENTS FOR ORGANIC MANUFACTURING, CIRCULATION AND LABELLING OF ORGANIC PRODUCTS” (№ 5448 FROM 24.11.2016)

OBJECTIVE: TO IMPROVE LEGAL FRAMEWORK ON ORGANIC PRODUCTION, CIRCULATION AND LABELLING OF ORGANIC PRODUCTS BY:



EXTENTION OF AUTHORITIES OF SSUFSCP

- MONITORING OF ORGANIC PRODUCTS
- STATE SUPERVISION OF CERTIFICATION BODIES' ACTIVITY
- STATE SUPERVISION OF BUSINESS OPERATORS' ACTIVITY
- MECHANISM OF INTERACTION BETWEEN SSUFSCP AND CERTIFICATION BODIES
- POSSIBILITY OF REQUEST TO EXCLUDE CERTIFICATION BODY FROM THE REGISTER OF CERTIFICATION BODIES



CLARIFICATION OF RIGHTS AND OBLIGATIONS FOR BUSINESS OPERATORS

- RETURNING OR EXCLUSION FROM THE MARKET PRODUCTS THAT DO NOT COMPLY REQUIREMENTS
- ANNUAL CONDUCTING OF CERTIFICATION
- COOPERATION WITH CERTIFICATION BODIES (INCLUDING LABELLING)



DETALIZATION OF REQUIREMENTS FOR PRODUCTION, LABELLING AND CIRCULATION OF ORGANIC PRODUCTS

- OBLIGATION TO PROVIDE DECLARATION OF ORGANIC PRODUCTION VOLUME



AMPLIFICATION OF RESPONSIBILITIES

- DETERMINATION OF PENALTIES
- NEW MECHANISM OF INFLUENCE ON CERTIFICATION BODIES



HARMONISATION OF UKRAINIAN LEGAL FRAMEWORK WITH EU LEGISLATION

- COUNCIL REGULATION (EC) NO 834/2007 OF 28 JUNE 2007 ON ORGANIC PRODUCTION AND LABELLING OF ORGANIC PRODUCTS
- COMMISSION REGULATION (EC) NO 889/2008 OF 5 SEPTEMBER 2008 LAYING DOWN DETAILED RULES FOR THE IMPLEMENTATION OF COUNCIL REGULATION (EC) NO 834/2007

UKRAINIAN CODE OF ADMINISTRATIVE OFFENCES

(ART. 167, 221, 225)
